

REGULATIONS FOR THE FISHING IN ÄLVDALLEN FVOF

The fishing license entitles only to one hand-tool/line per person.

All waters: Prohibited to use living bait.

Protected periods: Fishing is strictly prohibited in all running waters except in Österdalälven **from Sept 1 – April 30**. Fishing is prohibited in Österdalälven, 100 meters below the tunnel outlet at Åsen's power-plant from Sept 1 – May 15, however fly-fishing for grayling is permitted Sept 1 – Nov 30.

A total ban (Jan 1 – Dec 31) on fishing in the old river-bed between Åsen and down to the cement-bridge, due to fry/spawn-releasing.

Fishing is strictly prohibited during the period Sept 1 – Nov 30 in those lakes that the boards of directors select for fishing conservation. (See list in local paper or at www.alvdalenfvo.se).

Minimum size for grayling, trout and char is 30 cm. Exception **Österdalälven** where the minimum size is 25 – 35 cm for grayling and for trout 35 cm, and for **Rotälven** the minimum size is 20 – 30 cm and for trout 30 cm.

Bag limit: is 3 game fish (trout, char and grayling) per fishing license and day (24 hours) in **Österdalälven**. In all other waters the limit is 6 game fish per fishing license and day.

For the Put-and-Take fishing in Abborrtjärn the bag limit is 6 fishes per fishing license and day.

Fishing is strictly prohibited with any other tools than hand-tools: in Fisklösen, Lilla Knäsjön, Ljustjärn, Långtjärn in Loka, Lövtjärn, Mickeltjärn, Märråttjärn, Navardalssjön, Nässjön, Rutsjön, Rämmasjön, Skepphussjön, Stora Knäsjön, Stora Rensjön, Stora Sugntjärn, Storsjön (at Hållstugan) and Svartgessi (at Hållstugan).

In following waters it is also prohibited to fish from a boat: Abborrtjärn (by Tennådalsvägen), Brynåstjärn, Djustjärn (by Tennådalsvägen), Därå kalltjärn, Gummastjärn, Ingeborgstjärn, Kalvtjärn, Kolmarkssjön, Kropptjärnarna, KnutFadertjärn (at Hållstugan), Lextjärn, Lilla Blästtjärn, Lilla Sugntjärn, Lomtjärn, Mellan Sugntjärn, Måbergstjärn, Ormtjärn, Piltlokarna, Sjöbockstjärn, Stora Blästtjärn, Stortjärn, Stortjärn (at Hållstugan), Svartgessi (at Hållstugan), Tangeråstjärn, Tommostjärnarna, Tyttjärn, Urdtjärn and also in other lakes with game fish.

Fishing is strictly prohibited for petrol-powered boats in: Lilla Knäsjön, Lövtjärn, Långtjärn in Loka, Märråttjärn, Navardalssjön, Skepphussjön, Stora Knäsjön and Storsjön.

Fishing is strictly prohibited in the stream between Lilla and Stora Knäsjön, in the brooks between the Sugntjärn lakes (Sugntjärnarna), all inflows to Rämmasjön as well as in the stream between Rämmasjön and Sågdammen, in Mangravsbacken and Sigerajbacken that flows into Navardalssjön.

Within the Trängslet artillery Ranges (Trängslets Skjutfältsområde): In Broksjön, Mossibäck, Rivsövasslan, Rällan, Skärbergsbacken, Storbäcken and in all other streams north of Brosjön and have their outflows in Rotälven.

Belly-boating with hand-tools is only allowed in those lakes where fishing from boat is allowed, excluded lakes are Gummastjärn and Stortjärn where belly-boating is allowed.

Trolling fishing with no limit for amount of rods is only allowed in Trängsletdammen.

Fishing is strictly prohibited up streams the Trängslet dam-arm, in the partly drained river-bed between Trängslet and Storsugnet, 100 meters downstream the outflow of the canal in the old river-bed by Storsugnet and 100 meters downstream the outflow of the tunnel by Åsen's hydroelectric power station. Further is fishing strictly prohibited 50 meters downstream all other dams.

Information: The fishing license is valid in the whole of Glysjön, in the Trängslet dam up to Krypan within **Särna/Idre** fishing nursing district and down to Spjutmodammen's hydroelectric power station (**not below**) within the Mora/Våmhus fishing nursery district, in the water within an area defined by the main road 70 – Lövnäs road, the boarder to Transtrand and the boarder to Särna. An exception is privately leased waters.

The following waters are excepted from the fishing license: Hålltjärn (Loka), Simaven (north of the indoor swimming pool), Åsdammen's sport fishing, the demarcated water west of the main road 70 and private and joint dams within, settlements and chalets.

Recommendation: When fishing for grayling is recommended that barbless hooks are used in Österdalälven and in Rotälven.

Regulations for law and order and penalties: the fishing license and the fishing certificate are personal and cannot be delegated to another person. The fishing license must be signed by the holder and must be carried along with oneself when fishing. The holder must be able to identify him/herself. The fishing assembly can through the board of directors decide on limited right to fish due to measures regarding fishing conservation. The fishing can only be carried on for one's own use, not to be offered for sale with the exception of roach, which is allowed to be offered for sale. The fishing must be carried on with moderation and with the observance of good fishing conservation. Persons who are caught fishing without a fishing license or are breaking the above mentioned existing laws, the fishing law, the fishing regulation or other general laws/regulations runs the risk of being prosecuted according to existing laws.
